"Overview of the HELCO Gas Turbine power plant project upgrade for Hawaii Electric Light Co, Inc., Keahole Plant"

Mustang Automation and Control (MAC), a business unit of Wood Group Mustang, Inc. is the largest control systems integrator company in the world.
