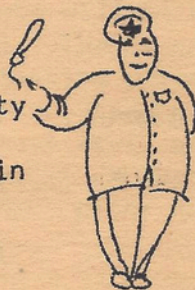

A GREETING FROM THE NEW CHAIRMAN

Preparations are now under way to carry on another year of activities of the Chicago Section. By the time the October issue of the NEWSLETTER reaches you, the Board of Directors will have held two meetings to straighten out a hundred and one details. We hope that the Section's activities will meet with your approval and that you will support these activities by attending the monthly meetings and by supporting the Section financially with payment of the nominal dues.

The House Committee, under the chairmanship of Bill Clarke (Putman Publishing), has already secured sponsors for some of the free social hours which now precede our dinner meetings. Their plans also include securing sponsorships for the next fiscal year so these sponsorships may be distributed over a period of two years, rather than every year. We hope you approve of the NEWSLETTER in its present form. Last year was our first year in presenting this type of bulletin. The mailing of about 1000 NEWSLETTERS a month to you for eight different meetings was becoming a big chore for the Secretary of the Section. Because of this, the Board of Directors decided to engage a secretarial and mailing service. This type of service, as compared to the low-expense type of support from the employers or former secretaries, has definitely increased our costs. An increase in dues of the Section seems to be in the offering as a result of this change.

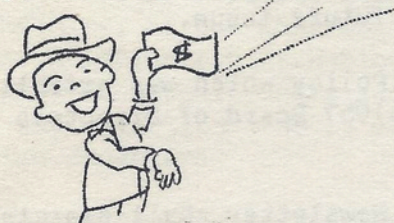

The following is the Editorial Policy which was established for the NEWSLETTER by the 1956-1957 Board of Directors of the Chicago Section:

1. The Editorial Board of the Newsletter shall exercise sole judgement to determine if editorials submitted to the Newsletter should be classed as controversial.
2. Should controversial subjects be submitted for publication, they are to be published clearly labelled as the opinion of the author. Further, it shall be stated that editorials in rebuttal are invited.
3. No release or publication of the Chicago Section shall be composed in such a manner as to be construed as promoting any commercial or profit-making enterprise.
4. All material to be published will be reviewed by the Editorial Board to insure that Article II of the Institute Constitution is not violated. Article II reads: "The objects of the Institute are the advancement of Chemical Engineering in theory and practice and the maintenance of a high professional standard among its members."
