This form is to be completed by the Group Leader. The Group Leader must be an adult (21 & older) and must accompany the group to the event. All communications surrounding the group's registration will be sent to the Group Leader.

### **Vaccination/Negative COVID Test Attestation & Proof**

AICHE requests that all 2022 AICHE Annual Meeting attendees, exhibitors and vendors to attest that they will be fully vaccinated for COVID-19 fourteen days prior to the in-person meeting OR have negative COVID-19 test results within 72 hours of arrival. Please be prepared to provide proof when you go pick up your badge.

### **Adult Supervision**

By submitting this registration form, the Group Leader understands that all K-12 aged attendees require supervision by an adult (21 & older) chaperone. The Group Leader understands that 1 adult chaperone is required for every 8 children in their group and verifies that all K-12 students in their group will be accompanied by the appropriate number of adult chaperones. The Group Leader understands that if the appropriate number of adult chaperones are not present, their entire group may be refused entry to the event.

### **Parent/Guardian Permission**

By submitting this registration form, the Group Leader verifies that they are either the parent/guardian of the K-12 aged students they are accompanying to this event, or that they have received the appropriate authorization from the parents/guardians of the K-12 aged students they are accompanying to bring their children to this event.

### **Medical Disclosure Statement**

By submitting this registration form, the Group Leader affirms that all children and adults in their group are free of any medical conditions that would prohibit or hinder their safe participation during this event.

### **Dietary Restrictions & Food Allergies**

A space is provided below for the Group Leader to communicate any pertinent information regarding dietary restrictions & food allergies of all members of their party. By submitting this form, the Group Leader verifies that they've communicated any pertinent information regarding dietary restrictions and food allergies of all members of their group. The Group Leader understands and accepts that AIChE will work with its vendors to label food offered during the event and within reason will provide alternative meal options for attendees with dietary restrictions/food allergies. The Group Leader affirms that they are ultimately responsible for understanding the dietary restrictions/food allergies of all members of their group, and for overseeing the safety of any members of their group with food allergies and addressing them accordingly.
